

From an environmental point of view. humanity already consumes 50% more in renewable natural resources than the Earth is able to regenerate. This is true at a time when only 1.1 billion, out of 7 billion people are responsible for 78% of total consumption. The emerging middle class will add another 3 billion people to the mass consumption market in the years ahead. More than four planets would be needed to supply all the goods and services that this expanded market will require assuming that the present models of consumption and production persist. To address this imbalance, a sustainable model of consumption is needed. Such

a model will require a complete redesign in the way products and services supply well-being to humanity. Consumers are increasingly aware of the need. for a more sustainable model of consumption. This presents a great opportunity for companies to drive arowth by redesigning the ways their products and services supply well-being to consumers. For consumers to recognize and value the new ways in which well-being is supplied, companies will need to play a role in educating consumers to change their behaviour when buying, using and discarding products or services. By capitalizing on these opportunities, companies will create sustainable benefits to society and the environment, as well as to themselves, the economy and individual consumers.
