



STEP 14: Compress the valve spring with a valve spring compressor and remove the valve retainers.



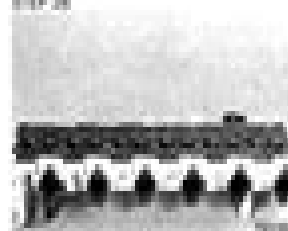
STEP 15: Remove the valve spring retainers and the valve springs.



STEP 16: Remove the valve and valve guide from the cylinder head. Clean the valve guide hole.



STEP 17: Remove and discard the valve spring seat from the cylinder head. If required.

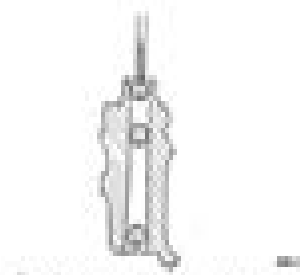


STEP 18: Clean the cylinder head thoroughly, removing carbon and other deposits. Check for cracks and any sign of damage in the area of the the ring grooves.



STEP 19: Check the cylinder head surface for warpage. Use a straight edge and feeler gauge. Check the flatness of the head. Use a feeler. Measure straight edges made for warpage at each valve and between of cylinders. Warpage of head is not to exceed 0.001 in. (0.025 mm) at any point.

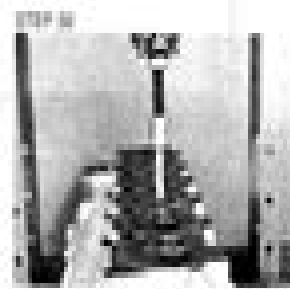
REMARK: If the measurement is more than 0.001 in. the cylinder head must be machined or replaced. Replace the cylinder head. The head height is less than 1.015 in. after the head is machined.



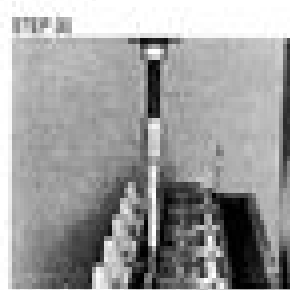
STEP 21: Clean the valve guide of both pistons with a wire brush.



STEP 22: Check the valve guide with a micrometer. If the difference is more than 0.001 in. the valve guide must be replaced.



STEP 23: Use the valve guide tool and a hydraulic press to remove the valve guide. Press on the bottom of the valve guide.



STEP 24: Use the valve guide tool and a hydraulic press to remove the valve guide. Press on the top surface of the valve guide.
